### **FINDINGS OF FACT**

- 1. The above-captioned matter was set to convene for hearing on March 10, 2022, at 1:00 p.m., at the Office of Administrative Hearings in Phoenix, Arizona.
- 2. On the date and time set for hearing, Ellen Davis, Esq. was present representing Beaver Valley Improvement Association ("Respondent"). William Campbell was also present as a witness for Respondent. Daniel Belt ("Petitioner") did not appear for hearing. No representative for Petitioner appeared by 1:10 p.m., Petitioner did not request a continuance, and Petitioner failed to provide any cause for such non-appearance. Ms. Davis made a motion to dismiss.

# **CONCLUSION OF LAW**

Petitioner bears the burden of proof to establish that Respondent committed the alleged violation as asserted in the Petition, by a preponderance of the evidence.<sup>1</sup> Because Petitioner failed to appear, Petitioner failed to sustain his burden to establish a violation by Respondent.
