ORDER

Pending before the Office of Administrative Hearings is Respondent's Motion for Summary Judgment pursuant to Rule R2-19-102(C) and Rule 56 of the Arizona Rules of Civil Procedure. Under Rule R2-19-102(C), "If a procedure is not provided by statute or these rules, an administrative law judge may issue an order using the Arizona Rules of Civil Procedure and related local rules for guidance." Pursuant to Rule 56 of the Arizona Rules of Civil Procedure, a party is authorized to move for summary judgment, and the court shall grant such motion, "if the moving party shows that there is no genuine dispute as to any material fact and the moving party is entitled to judgment as a matter of law." See A.R.C.P. Rule 56. Petitioner has not responded to the Motion.

Petitioner has also filed a Motion to Dismiss three of four issues identified in the Petition in part because Petitioner has not paid the proper filing fee. Petitioner has paid \$500.00 for four alleged violations: (1) violation of A.R.S. § 33-1804(E)(2) regarding an emergency meeting of the Board members, (2) violation of A.R.S. § 33-1804(A) with respect to the March 25, 2021 Board meeting, (3) violation of A.R.S. § 33-1804(A) with respect to the May 27, 2021 Board meeting, and (4) violation of the Association's Collection Resolution. Each allegation alludes to a different set of facts. Petitioner also alleges through the Petition that Respondent violated A.R.S. § 33-1804(A),(E)(2),(E)(3), and section 6.4 of the CC&Rs. However, Petitioner has only paid \$500.00.

Having reviewed the Motion to Dismiss and the Motion for Summary Judgment, IT IS ORDERED denying the Motion to Dismiss for lack of jurisdiction due to Petitioner's failure to pay the appropriate filing fee. Rather, no later than May 6, 2022,

Petitioner must render the additional \$1,500.00 filing fee to the Arizona Department of Real Estate for the four identified issues in the Petition.

IT IS FURTHER ORDERED that the Motion for Summary Judgment and Motion to Dismiss are denied on all other grounds.
