**ORDER** 

A rehearing in the above-entitled matter is scheduled for August 1, 2022. Petitioner Anthony T. Horn filed a petition alleging that Respondent Sun Lakes Homeowners Association #1 violated Arizona Revised Statutes (A.R.S.) § 33-1804(F) with respect to the July 6, 2021 Board of Directors meeting. The petition did not include an allegation that Respondent violated A.R.S. § 33-1804(D) with respect to a November 9, 2021 Board of Directors meeting (Nov. 9th meeting).

Respondent has filed a motion requesting an order to limit the scope of the hearing to an alleged violation of A.R.S. § 33-1804(F) with respect to the July 6, 2021 Board of Directors meeting (Motion).

Petitioner filed a response to the Motion,

Having reviewed the Motion and Petitioner's response,

**IT IS ORDERED** that the sole issue to be addressed at the hearing is whether Respondent Sun Lakes Homeowners Association #1 violated A.R.S. § 33-1804(F) with respect to the July 6, 2021 Board of Directors meeting.

**IT IS FURTHER ORDERED** that Petitioner may introduce evidence to rebut Respondent's claim that any alleged violation of A.R.S. § 33-1804(F) was cured through the November 19<sup>th</sup> board meeting, including notice of the meeting.

IT IS FURTHER ORDERED that Petitioner must immediately pay an additional filing fee of \$500 to the Arizona Department of Real Estate, no later than July 14, 2022, if Petitioner desires to include the issue of an alleged violation of A.R.S. § 33-1804(D) with respect to the Nov. 19<sup>th</sup> meeting.
